My "cousin" Kevin Hoeg, asked what i could contribute about Sheriff Joseph R. Hoag. After a bit of research i found his family and history. And he is my 4th cousin 2x removed, as he is descended from where all New England Hoags are: Richard Hoag (1602-1683) from England to Massachusetts in the mid 17th century. So here is what i found! Josiah Rogers Hoag aka Joseph was born on January 13, 1833, in Concord, New Hampshire, his father, Charles Hoag, was 41 and his mother, Eliza (Purington Rogers), was 29. He had one brother and three sisters. Josiah, as far as i found, remained single all his life and probably died in Nevada after 1900. His family moved west to Wheatland, Illinois by the 1850 US Census. He alternated using Josiah and Joseph throughout his life. I am confident it is the same person. Below is a PDF document i created summarizing his life with the records i found. Unfortunately i found no photo or obituary. I would enjoy your sharing what you know about his exploits in Silver Reef??!! I hope to visit your museum sometime! Best,

The older generation Hoags were Quakers, but i can't tell about this branch. Josiah "Joseph" Hoag's parents and family were buried here: <u>Charles Hoag (1791 - 1860) - Find A Grave Memorial</u> (Non-denominational?) Joseph's brother was **Thomas Clarkson Hoag** (1825-1906). Born in Concord NH and died in Los Angeles. Buried with parents in Chicago.

Sometime between 1880 and 1896, he moved to Los Angeles from Evanston, Illinois. So it was possible he was passing through Salt Lake City in 1888? But returning to Ohio doesn't seem to fit, but i don't know where Thomas was living in 1888. (1880 US Census was Evanston, IL.)

Let me know if you find Joseph's obituary?

The <u>Compiled Laws of Utah</u> for 1878 gives an account of the incorporation of Silver Reef by the Legislative Assembly; however, this incorporation never actually became law and the town was never incorporated. 33 Another attempt was later made which failed also because the mining companies and business men who feared taxation opposed the movement. 34 Town officials were Deputy Sheriff Joseph Hoag who was the town constable during most of its active history (he handled with outstanding courage the many problems which arose) and Justices of the Peace Kiv Phillips, Benjamin Paddock and J. N. Louder.

Nominations for Sheriff being now and nounced, Jos. R. Hoag, Geo. W. Birdall and D. W. Newman were placed in nomination. Upon the ballot being sounted, it was found that Geo. W. Birdsall had received 20 votes; Jos. R. Hoag, 10; and D. W. Newman, 5. Geo. W. Birdsall was declared the nominee of the Convention.

CAUGHT .- Sheriff Gilmore of Eureka J. R. Hong and Phil. Barnhart returned on yesterday's Salt Lake stage, having in charge George Watkins, an escaped fugitive from justice from Eureka coun ty. He was indicted by the Grand Jury of that county for grand larceny and other offenses, and was released from custody on giving good bonds, but no having faith in his own innocence, or not liking to stand a trial, he fled from Enreka, leaving his bondsmen in the lurch. Hearing that he had passed through or near Pieche, Sheriff Gilmon telegraphed to this place to have him stopped. Joe Hoag and Phil Baruhar were accordingly dispatched out on the Salt Lake road for him. They succeed ed in effecting his capture at Corn Creek, the other side of Beaver, and were returning with him when met by Sheriff Gilmore, who left Pioche on Morday's stage for the purpose of getting hold of him. He was brought to town yesterday afternoon and lodged in the County Jail, and will be taken back to Eureka to-ony. His capture saves the confiding bonds men from a large loss .- Pioche Record, Sept. 1.

Silver Reef Social Club.—A club for the purpose of giving dancing parties was organized in Silver Reef, Utab, on the 19th of January. They gave their first grand hop on Thursday evening. A number of old Piochers helped to compose the club, among whom are Julius Sultan, T. J. Dowell, Al. Hamilton, Joseph R. Hong. Chas. Bowen and Jas. Cronin. We are under obligations to this club for an invitation.

Silver Reef Miner Oct 28., 1882

A horse race comes off on Saturday the 4th of November between Gordon's black and Shoemaker's sorrel, for \$100.00 a side, homestreach. The money was put up yesterday in the hands of Mr. J. R. Hoag.

Pioche Weekly Record, May 5, 1888 – Met brother Thomas in SLC who was apparently on his way back from California; reference to home being in OH may be an, as he was may have still been living in IL - I think that Joseph had moved to Pioche by this time.

J. R. Heag left for Salt Lake City on the 15th ult. to meet his brother, whom he has not seen for more than twenty years. Mr. Hose and family have been to California on a pleasure trip and are now returning to their home in Ohio.

J. R. Hoag and J. A. Turrell returned on the 20th ult. and have again placed themselves on the payroll by resuming their old occupations. J. R. Hoag looks much improved after his trip and his numerous friends here are pleased to see him about once more. Mr. Turrell says that Selt Lake is improving, and that the church is growing in membership.

Death of Joseph Hoag.

Joseph Hong died at Delamar last evening. He had been in poor health for the past six months, and gradually got worse until death releived

him of his suffering.

He was upright, honest and a valued citizen. For the past four years lived at Delamar and filled the office of Justice of the Peace of that Township.

He will be buried to-morrow.
